OFFICE MEMORANDUM

Subject: Extension of validity period of Consent to Establish/Consent to Operate/Authorization/Registration expiring between 28.04.2021 to 30.06.2021.

Whereas, the Section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21/22 of the Air (Prevention & Control of Pollution) Act, 1981, under Rule 6 of the Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016, Rule 10 of the Bio Medical Waste Management Rules, 2016, Rule 13 of the E-Waste (Management) Rules, 2016, Rule 13 of the Plastic Waste Management Rules, 2016, Rule 16 of the Solid Waste Management Rules, 2016 mandatorily provides for obtaining consent, authorization and registration for establishment/operation respectively from the Board. It has been observed from the records of the Board that, the consent to operate of industries are expiring between 28.4.2021 to 30.06.2021.

Whereas, consequent to outbreak of 2nd wave of Corona Virus (COVID-19) and subsequent lockdown imposed by the State Government, the industries/activities are finding it difficult to apply and obtain renewal of consent to operate/authorization/registration and extend CFExp validity under the various Acts and Rules mentioned above.

In view of the above, the Karnataka State Pollution Control Board by virtue of powers conferred under the Section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21/22 of the Air (Prevention & Control of Pollution) Act, 1981, under Rule 6 of the Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016, Rule 10 of the Bio Medical Waste Management Rules, 2016, Rule 13 of the E-Waste (Management) Rules, 2016, Rule 13 of the Plastic Waste Management Rules, 2016, Rule 16 of the Solid Waste Management Rules, 2016 hereby extend the validity of consent to operate/authorization/ registration and CFExpansion whose validity period ends between 28.4.2021 to 30.6.2021 as under :

1. The extension of validity is subject to same terms & conditions stipulated in the previous CFExp/CFO/Authorization/Registration issued by the Board.
2. The extension is granted for a period of 3 months from the respective date of expiry;
3. The extension is subject to otherwise eligibility such as lease, etc
4. The respective proponents/industries/activities shall apply for renewal within the respective extended date available to them.
5. The renewal when granted, shall be effective from the date of expiry of previous consent.

This OM will come into effect immediately and issued with the approval of the Competent Authority.
